With regards to our local plans consultation I wish to have added my comments. Could you please see that these are added

(1) In my opinion the Railway Station for Cullompton does not show any imagination and is sited in the wrong area of Cullompton. I am not sure the Rail Track would allow it to be sited nearly opposite the Weary Traveller as now proposed just coming from a curve section of the track.

It needs to be sited Taunton side of the M5 intersection at 28 beyond the motorway services to allow for future parking requisites and possible future goods usage.

(2) With Cullompton expanding and having a motorway junction at 28 there is a need for a bus station and interchange which meets the needs of both rail and public passengers in our area to be included.
