

Mid Devon District Council made an immediate Article 4 (1) Direction that came into effect on 17 December 2015 under Article 4(1) of the Town and Country Planning (General Permitted Development) Order 2015. This supersedes the previous Article 4(2) Direction (made and confirmed in 2009) which was cancelled on 17 December 2015.

The Article 4(1) with immediate effect applies to dwellinghouses in the Cullompton conservation area. Development of the descriptions set out below in schedules 1-6 (namely installation of rooflights, works to chimneys, construction of porches, demolition of boundary walls, replacement of doors and windows) shall not be carried out on the properties listed in those schedules, unless planning permission is granted on an application made under Part III of The Town and Country Planning Act 1990 as amended.

This Direction shall in accordance with Schedule 3 paragraph 2(6) of the said Order expire six months from the date this Direction is made unless it has been confirmed by the Council before the end of that said 6 month period. Any written representations concerning the Cullompton Article 4(1) Direction with immediate effect must be made to the local planning authority by **15 January 2016**.
