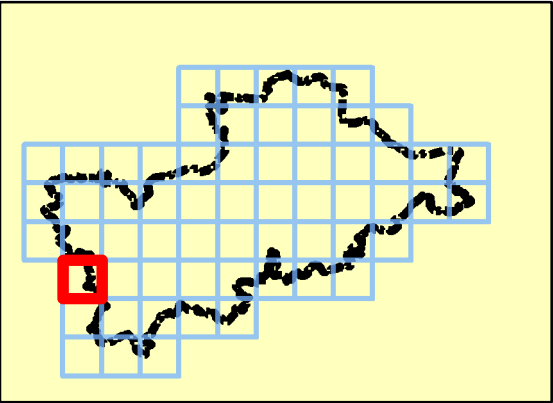
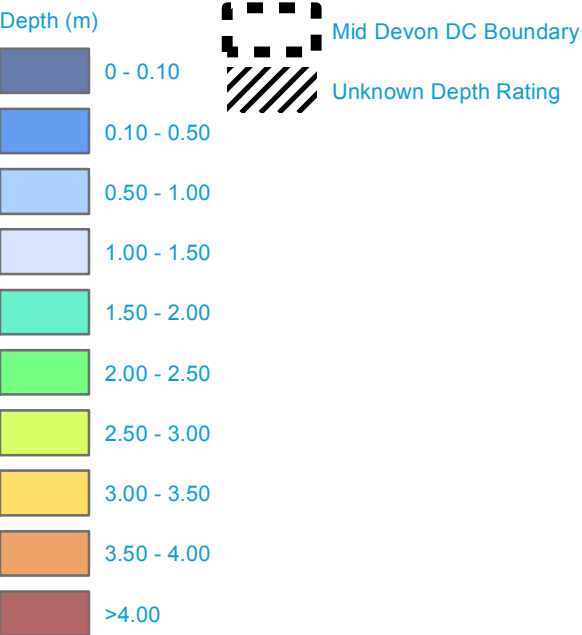

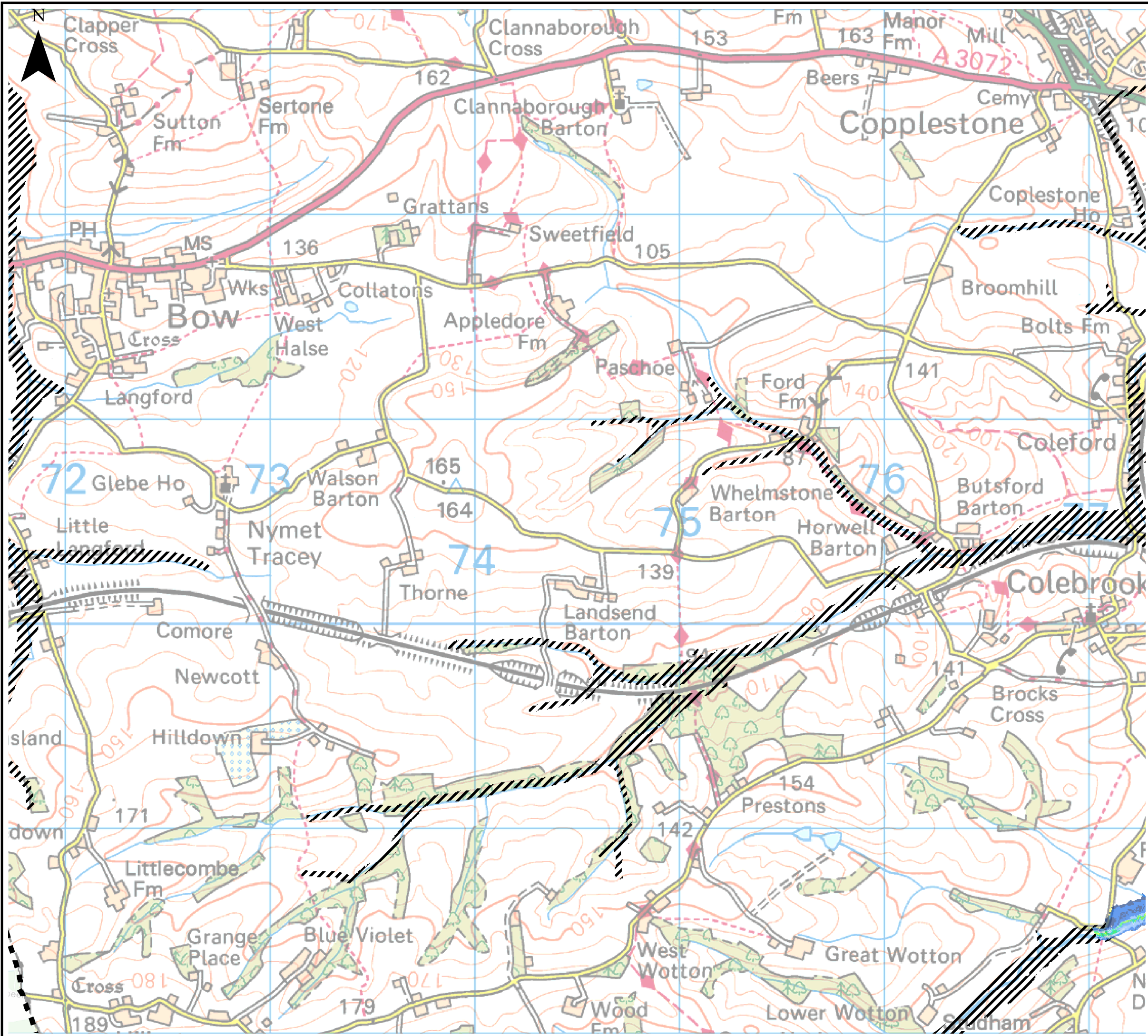
DEPTH MAP - 1 IN 1000-YEAR EVENT
