### **Re: Refuse Storage for New Residential Properties – Supplementary Planning Document**

Mid Devon District Council is carrying out a second stage of consultation on a new Supplementary Planning Document which will provide guidance on the design of waste and recycling storage for all types of residential properties in Mid Devon. The SPD will apply to the whole of Mid Devon, except for a small area of Cheriton Bishop parish within Dartmoor National Park.

The Council conducted an initial consultation from the 23 May 2016 – 18 July 2016 on the content of this new SPD. A total of 9 valid responses were received and have been considered when producing the draft SPD.
