I hope the examination of the Crediton NP is going well.

Regarding your queries:

- I've noticed that Map 5 Views was mislabelled and should be Map 6 Views. Policy En5 refers to it as Map 6, which should explain the missing map. I believe policy En4 refers to Map 5 Green Corridors and Map 6 mentioned in the policy is a typo, should be Map 5. However, I wanted to be sure, so I have forwarded your question to the Crediton NP Group.
- I've checked maps on pages 11, 25 and 38 in our version of the Crediton NP and they are blurry as well. I have emailed NP Group if they could provide original maps. I hope they can and will send those across as soon as I receive them.
- The Regulation 16 consultation ran from 22nd Nov 2021 to 14th Jan 2022.

I hope my answers will be helpful.
