We often miss key community information as we do not get the Willand or Uffculme newsletters, eg events for children in the holidays, the fireworks at Bridwell (which borders our field!), information re Road closures etc. We sometimes get a Halberton magazine, but not every issue and a lot of the info is irrelevant. I did consider volunteering to distribute the magazine for our area but realised I'd have to collect them from Halberton and I simply don't drive through Halberton being so close to J27 and the link road. We feel that the logical boundary to the parish is the M5. We don't benefit from money being spent to improve facilities that we would use or the general area or clubs within the parish. We are also concerned that decisions made about our patch of the parish don't affect Halberton residents eg the expansion of Hitchcocks business Park. Residents of Halberton are not affected by the noise and additional traffic, or lorries shaking their windows and floors! But they do benefit from the extra rates etc that the park has to pay. We do not drive through or attend any events in Halberton and do not feel part of the community. We have felt for a long time that we are in the wrong parish and welcome the opportunity to express our views.

Comments for: It is frustrating that the village of Yeoford does not have its own parish council. I live in Yeoford and served on Crediton Hamlets Parish Council for four years. The shape and structure of the council is bizarre, incorporating streets on the outskirts of Crediton (and more oddly, the big Tesco supermarket on the other side of the town from us) as well as Yeoford and then swathes of countryside. The council is split into two wards, with just over half the councillors representing Yeoford and the others representing Hookway, an area of farmhouses and tiny hamlets close to Crediton. Often seats on the council are 'fixed' so that members resign if new councillors come forwards and are then co-opted back on to represent Hookway ward. Yeoford is a thriving community with a pub, a village hall, a recreation ground, a play area, a school, a church and a railway station which has grown markedly over the last few decades. During my time on and off the Parish Council, I have found it frustrating trying to get support for Yeoford. The reason given for the lacklustre attitude is always that the Parish Council covers other areas too, even though only Yeoford has community amenities in the parish. I would like to see a Yeoford Parish Council that covers the village and hamlets that are

close enough to use the village amenities (e.g. Neopardy and Woodland Head) rather than Crediton. I believe this would be empowering for our village and enriching for our community.

The area to the north of the A377, to be reallocated to Crediton and Copplestone. Please find attached Willand Parish Council's response to the invitation for comments at the first stage of consultation as part of the MDDC Parish Review.

### **Submission 23**

Date: 19/01/2022 Willand Parish Council Response of Willand Parish Council

### 1. Introduction.

- 1.1 Willand Parish Council has been trying to achieve a change to the Parish Boundaries between Willand, Halberton and Uffculme since 2002 when representations were made to MDDC and so these approaches should be well documented and available to the Committee.
- 1.2 Since that time Willand and Uffculme Parish Councils have worked together to try and achieve a change. Halberton Parish Council has been approached but understandably wish to retain the current position.
- 1.3 This document sets out the position currently and the reasons and argument for change. It also sets out an even greater change for consideration in the light of potential developments for the future which could lead to the expansion of the communities of Willand and Uffculme.
- 1.4 A detailed submission was again made to the Chief Executive in March 2017 and this current document updates that submission but Maps at Appendix 'A' and Appendix 'B' are repeated by attachment to this document. Also attached, at Appendix 'C', is a letter which was sent to the Chief Executive in October 2017

which sets out the frustrations being experienced by even further delay. Since then a Ward Boundary Review by the Boundary Commission has been used as a reason for further delay.

### 2. Geography & History.

- 2.1 Willand has grown in population considerably over the past 20 years as has Uffculme, the latter with more modest numbers of housing. More houses are being built or have been approved for both villages. Sadly, infrastructure and facilities have not been provided to match the expansion of housing and population.
- 2.2 Halberton Parish acts as a 'buffer' between Willand, Uffculme and Burlescombe Parishes in places. The bulk of the Halberton land is open countryside or farms with little population. Halberton has a history which it understandably wishes to protect in that on the edge of Uffculme is Bridwell Park and House which is listed. If one looks at a map that property can be seen to be more relevant to Uffculme than Halberton.

  2.3 With the building of the M5 motorway there is a section of Halberton Parish land to the East of the M5
- which is in effect cut off from Halberton [the Halberton Bulge]. To the North is the boundary with Burlescombe [a long way from either actual village]; to the East Uffculme; to the South Willand and to the West a natural boundary formed by the M5 and then further South the Splatford Stream. This area [the Halberton Bulge] of Halberton parish has only a very small population and can only be accessed via Willand or via Sampford Peverell and Burlescombe parishes via the A38 and B3181. This area of land, apart from ancient history, has no relevant current connection with Halberton Parish or community.
- 2.4 In past years a development known as Culm Valley Way was built on Halberton Parish land but was really an extension to the west of Uffculme. As the residents of this new development were using Uffculme facilities the parish boundary was eventually 'modified' to include this section of land in Uffculme.
- 2.5 Willand and Uffculme Parish Councils have been working together to try and achieve parish boundary changes since 2002. Various 'excuses' have been put forward by officers at Mid Devon District Council, usually to wait until after the next election. They were then assured that it would be looked at after the 2019 election to be ready for any agreed change by the 2023 election. A map of the current Parish Boundary is attached at Appendix 'A' and proposals for Parish Boundary changes is attached for information at Appendix 'B'.

# 3. Practical Implications.

- 3.1 The residents of the Halberton Bulge pay their parish council tax precept to Halberton [a lesser amount than Willand or Uffculme] but in fact they use the facilities of Willand and Uffculme. This includes the Village Halls, Primary Schools, Pre Schools together with play areas and such sports facilities as there are. Uffculme and Cullompton Secondary Schools are used as opposed to Tiverton which has Halberton Parish as its catchment area. There are also allotments and community composting facilities. The local churches, shops and post office facilities are also used. They do not travel to or identify with such facilities in Halberton.
- 3.2 There are four business parks in this *Halberton Bulge* some of which are still expanding. They are closer to, and more relevant to, Willand or Uffculme BUT these Parishes are restricted in representation at planning meetings. Ward Councillors also have speaking time restrictions placed upon them as it is not in their Ward but Halberton Parish Council rarely make an objection or reasoned response to planning applications in this area of the parish. It has no physical or administrative effect on them but most have a very noticeable effect on Willand and/or Uffculme.
- 3.2.1 Langlands Business Park has developed from 'farm diversification' and is on the edge of Uffculme but accessed from the B3181 and then B3440 via a large roundabout in Willand. It is Halberton Parish but has a daily effect on Willand/Uffculme.
- 3.2.2 Hitchcocks Farm Business Park has grown from a 'farm diversification' into a large major award-winning business park which is still being allowed to expand and is in effect almost infilling between Willand and Uffculme. Halberton Parish but accessed and more relevant to Willand and Uffculme Parishes.
- 3.2.3 Willand Road Business Park just clips the edge of Willand Parish Boundary and is a smaller area of a few large units. Halberton Parish but nearly in Willand.

- 3.2.4 Mid Devon Business Park Phase 1. This is shown on maps as in the Willand Settlement Area but only a small portion of it is in Willand Parish, the bulk being in Halberton. Phase 2 has now been approved and is all in Halberton Parish but within the Willand Settlement Area. Both Phases can only be accessed through Willand.
  3.3 There is one large development under construction next to Uffculme together with a number of isolated residences and a small 'hamlet' in Muxbeare Lane which are within the Halberton Parish.
- 3.3.1 A site of 90 houses is being built on a site known as Harvesters [now named Lucombe Park]. This site is on the road between Uffculme and Willand on the outskirts of Uffculme. It is in Halberton Parish yet all of the facilities identified to support the application are in Uffculme. Currently S106 monies are to be used for limited infrastructure improvement in Uffculme but the council tax goes to Halberton.
- 3.3.2 Residents of Muxbeare Lane and the farms in the *Halberton Bulge* may seek to be buried, or have ashes interred, in Willand Cemetery. They must pay double the fee at present as they are not residents of Willand and do not subscribe to the costs of maintaining the facility.
- 3.3.3 Unless registered for postal voting the residents of these areas have to travel to Halberton to vote but if they were in Willand or Uffculme they, in most cases, would only have to walk a few hundred yards to a polling station.
- 3.3.4 Residents of these areas used not to be able to be married in Willand or Uffculme churches but had to go to Halberton. When the parishes of Willand and Uffculme recently attempted to have the parish boundaries changed the church looked at changing their boundaries to be in alignment and have done so in a short time thus removing this administrative problem. Regrettably MDDC has not moved the parish boundaries to reflect the current position.
- 3.4 All of these practical issues identify that the *Halberton Bulge* is impractical by being retained in the Halberton Parish and all factors suggest that the area would sit more comfortably and practically in Willand or Uffculme Parishes.


# 4. The Planned Future.


- 4.1 The Local Plan allows for a major 'tourist' development in the region of Junction 27 of the M5. As boundaries are at present many refer to this development being at Willand but it is not. It will in fact involve three parishes, none of which is Willand.
- 4.2 The proposed developments could be contained within Willand if the boundary is moved, even further than currently proposed, to have the M5 as the western boundary from Willand to Junction 27 and then follow the A38 to Waterloo Cross and up to the Appledore area of the A38 where it meets the natural existing boundary for Uffculme.
- 4.3 Willand Parish Council has commenced the process of producing a Neighbourhood Plan. With the parish boundaries as they are, and the suggested Ward Boundaries not helping resolve the issue, it is becoming an almost pointless task as there will be no sensible definable 'Neighbourhood' if the *Halberton Bulge* remains as part of Halberton Parish.

# 5. Conclusion.

- 5.1 As a rural area, for the reasons given, it is argued that significant weight should be attached to boundaries following communities (as per Guidance on Community Governance Reviews) thereby allowing for and maintaining community cohesion, both in reality and representation.
- 5.2 It is suggested that the *Halberton Bulge* to the east of the M5 should be absorbed into Willand and Uffculme Parishes. It would be more practical, looking to the potential future developments, to also extend the boundary up the M5 and onto the A38 as outlined in paragraph 4.2 above.

# Proposed Boundary Change Halberton - Uffculme - Willand

The Parish Council are extremely concerned as to the way MDDC Paid Officers are dealing with this issue. It is more a case of the fact that the issue is not being dealt with in an expeditious and efficient manner.

On 7 May 2002 the Parish Council wrote to the then appropriate Secretary of State concerning changes to our parish boundary. It is understood that the relevant documents were copied to MDDC and Ward Councillors. The document is attached as one file. Nothing happened.

On 6 November 2014 the Parish Council wrote to Councillor Chesterton, not only as a Ward Member but also as portfolio holder for Planning and Regeneration. A copy of the letter is attached with paragraph 10A the most relevant to this issue. The other Ward Councillors were copied. Councillor Chesterton requested a meeting to discuss the issues and the meeting was held on 12 November 2014 at which notes were made. The relevant note reads "Question 10A – RC wished to 'wait and see' but KG and BW felt that this was not acceptable as then it would either be too late or some other excuse would be made to disadvantage Willand. After further discussion RC agreed to start the process of trying to coordinate the parish and settlement area boundaries. *Action:- Richard Chesterton.*"

A verbal response was subsequently received to the effect that the Chief Executive would look at it after the MDDC elections [2015]. NOTHING FURTHER WAS HEARD.

At the end of 2015 and during 2016 discussions took place between Uffculme and Willand Parish Councils resulting in a document being prepared and sent with a covering letter to all Ward Councillors with appropriate maps in March 2017. All these four documents are attached.

On 28 March 2018 Councillor Chesterton sent an email – "In reference to your letter I have now heard back from Stephen Walford who has confirmed that Jackie Stoneman would be your contact at MDDC to discuss initiating a review of your parish boundaries. There is a process, which I'm sure Jackie can explain fully which I believe starts with a petition that could lead to a community governance review.

It might be best though to hold off any contact with Jackie till after the County Council elections as all her time will be taken up in the short term."

Jackie confirmed this in an email the same day.

The County Council elections came and went and then the delay was for the General Election. Nothing further was heard. FIFTEEN YEARS have passed from when the process was first started.

Further enquiry was made and on 14 September 2017 the following email was received from Councillor Chesterton – "Please can I pass on my apologies for tonight.

Could I also please report on a conversation that I had yesterday with Jackie Stoneman of the Elections team. I know Willand and Uffculme have a desire to review the parish boundaries.

Jackie informed me that it is her intention to hold a review of all Parish Boundaries in Mid Devon, prompted by the requests made for a partial review. However this review is unlikely to be concluded by the Parish Election in 2019, which might be that they would officially come into being in 2023 if that is the case."

THIS WILL BE 21 YEARS FROM WHEN THE ISSUE WAS FIRST RAISED.

Currently we have planning applications being submitted in Halberton Parish where Uffculme and Willand Parish Councils are not consulted under Planning Policy Guidelines. Our Ward Councillors and Parish Councillors are advised by officers that they cannot speak at planning meetings as the case is not in our Ward/Parish. Fortunately, the Chair of Planning Committee has taken a more practical position when approached recognising that the sites will have more of an impact on Uffculme and Willand than on Halberton. The same has happened with an appeal case. With all the speculative applications brought about by the failure to prove a five-year land supply and the further delay with the submission of the local plan this can only get worse. Our Member of Parliament is encouraging more local involvement and supporting the concept of local plans but this is not a practical prospect when we have such out of date and impractical boundaries and procedures.

Will you please look at this issue with a view to achieving a way forward now and not subscribe to further prevarication and delay.

This boundary anomaly has left us in a dire situation whereby the land around us (which is part of Uffculme village but fall under Halberton) is being aggressively developed. 

Comments for: I am emailing on behalf of Hittisleigh Parish Council, regarding the Parish Review. We have discussed this matter at Parish Council and we have consulted with people within and on the edges of the current parish boundary. We appreciate that this is the first stage of the consultation process and that any changes are unlikely to come in to effect until 2023. Our comments and suggestions are made in the context of the actual local Hittisleigh community being considered wider than the current parish boundary, alongside the historical 'carving off' of sections of Hittisleigh to other parishes in times past.

Hittisleigh Parish Council recommend the following:

- In the westerly direction the boundary would extend from West Ford Farm, along the river to the lane beneath West Fursham Farm and include West Fusham, East Fursham and Easton Barton see map attached to this email. This addition to the parish would meet at Fursham Cross.
- In the easterly direction from Hittisleigh Mill, the new boundary would run up the Yeo river to Binneford, continue up the lane to meet the lane from Yeoford, turn left and then right down Road Down Lane and meet the existing boundary below Road Down Farm. Again see the attached map. Properties on the eastern side would include East Church Farm, Shortridge Farm, Trevince, Binneford House, Binneford Farm and Binneford Studio, Summer Corner, East Binneford Farm, Summerhill Farm, Woodside Bungalow and Road Down Farm.

A number of residents in these properties feel strongly that they would like to be within the Hittisleigh Parish, rather than within parishes with hubs at significant distance and to which they have less community connection. Several residents note that within their lifetime their property has been removed from Hittisleigh Parish, that their postal address is actually Hittisleigh and that they would like to be back within the Parish.

There is no logical reason for any of the land lying to the east of the M5 to remain in Halberton Parish; the M5 motorway is a massive barrier and had a similar physical feature been present 600 years ago, or whenever parishes were first created, the parish of Halberton would be vastly different as it is today. Not withstanding the above, current issues that concern me with Bridwell are such things as litter and planning. It is common knowledge that I am in the process of opening up Bridwell to wider appeal and as things stand my immediate village, Uffculme, are often kept in the dark with such proposals as they are not automatically advised, even though such proposals would clearly affect them, but perhaps not Halberton. Comments for: It's a good idea to review parish boundaries as the towns in Mid Devon have expanded into surrounding green fields often in another parish. In terms of sustainability, it's crucial that developments are connected to the towns and to each other by active travel routes and public transport. It's important that people in the new developments feel themselves part of the community to which they are attached and that they use all the services the town provides, including its democratic bodies. It doesn't make sense to me to have some houses outside the town boundary but inside the urban settlement that elect and pay tax to a rural council that serves a different kind of community, with different priorities and interests. Where new towns or communities are to be established in a rural area, and which are expected to be larger than any other community in the existing parish, it could be appropriate to ensure that the new community has its own identity. This might or might not require a new parish and it may or may not be feasible. If it destroyed the integrity of the existing parish (by taking a large chunk out of the middle of it, for example), that could be counterproductive if the remaining area lost its cohesion. Alternatively, the affected parish might have to decide whether they wanted to take on a large entity with an urban character and different needs within their boundary.

In my view, the priority is to keep communities coherent in geography and governance whatever teir size.

Appendix 2 (Boundary Review) 10/2/2022

Sandford Parish is in the District of Mid Devon and is situated approximately two miles north of Crediton and some ten miles from Exeter. The parish comprises the village of Sandford and the hamlets of Newbuildings, West Sandford and East Village together with outlying farms and cottages with a total population in excess of 1200. Sandford is a large rural parish with a great sense of community, and has two pubs, a community shop with Post Office owned and run by the community, a primary school, a recreation ground, plus a Parish Hall and two Churches and many local organisations and clubs. There is also a dedicated footpath/cycleway from Sandford village to Crediton via the 'Millennium Green'.

The Parish Council, at their Meeting, on 3rd February 2022, discussed the MDDC 2022 Parishes Boundary Review.

It was not felt any major changes were necessary to the number of Parish Councillors (currently 12).

Or to the Parish Boundaries to which we are currently in the process of replacing our missing Boundary stones. However it was agreed to accept a suggestion to include "Knathorne" and "Rolestone" (on the boundary with Sandford and Morchard Bishop) to be included inside the Sandford Parish Boundary. Parish Morchard Bishop Parish Council are aware of this proposal.

Comments for: Crediton Town Council welcomes the Parish Review. For several decades there have been 50 houses inside the town settlement considered to be part of the town, but which are outside the town boundary with occupants paying council tax to another parish. Now, with the prospect of a major development of 257 houses being inside the settlement but outside the boundary and paying council tax to another parish, it is time for these anomalies to be ironed out. All existing houses in Westernlea and all of the proposed Creedy Bridge development should be inside the Crediton parish boundary and it should therefore be amended to accommodate them. When new developments are added to the town, it is essential that residents identify with it. Connectivity for active travel are important, not just for carbon reduction, but also in ensuring that people feel integrated and included physically in the town envelope. Equally, the sense of belonging to a community and having a stake in it are essential in developing a successful and resilient town. For democratic coherence it also makes more sense for residents of such new developments to be able to vote for the council of the town where they live and to contribute to its services through the parish share of their council tax. Given the length of time it takes to do a boundary review, when the next local plan is begun and sites are called for, all those that are considered viable should also be reviewed to see what impact they have on the town in terms of governance as well as settlement implications. Towns and villages are very protective

of their identities and it's the identities and integrity of communities that should be considered when forward planning and governance meet.

Halberton Parish Review - Notes

### **Executive Summary**

Halberton Parish Council is responding to the request from Mid Devon District Council to contribute to the Parish Review currently taking place across the district.

The Parish Council, in carrying out its duties for the residents of Halberton Parish, strongly supports retaining the current parish structure and the vast majority of the existing boundary.

It is recognised that the Lucombe Park development to the East of the parish is effectively an extension of Uffculme village and, for the benefit of those residents, Halberton Parish Council proposes that solely the Lucombe Park area of the parish be ceded to Uffculme parish. But could equally be serviced by Halberton Parish due to the proven track record of servicing outlying areas such as Ash Thomas, Brithem Bottom, Seckerleigh.

Halberton Parish Council has engaged with Uffculme and Willand parish councils regarding this Review, and strongly disagrees with their proposals to annexe other larger areas of Halberton Parish. Those proposals offer no tangible benefits to the affected population, whilst showing little or no respect for the neighbouring communities.

### The Parishes of Devon

Civil parishes can trace their origin to the ancient system of ecclesiastical parishes which historically played a role in both civil and ecclesiastical administration. Civil and religious parishes were formally split into two types in the 1860s and of course are now entirely separate.

# **Halberton Parish**

Halberton's name is derived from "Haligbeort" (Albert), the name of the Saxon Chief, and "tun", a farm settlement.

Halberton was once important enough to be a "Hundred", an administrative division of a shire. This included the parishes of Halberton, Sampford Peverell and Willand, as well as parts of Uplowman and Burlescombe. Many of the farms date back to Doomsday or shortly after and Halberton is still largely a farming community with a strong rural identity.

# **Parish Communities**

In a rural District such as Mid-Devon, the communities outside of the main towns comprise a large number of small hamlets, some modest villages with limited services and a few larger villages with a wide range of services serving the immediate and surrounding areas.

In 2011, Halberton parish had a population of 1,765.

Of these, 865 lived in Halberton village and 900 lived in the outlying hamlets, including Ash Thomas, Brithem Bottom, Mountstephen and Selgars.

In 2022, prior to the 2021 Census being released, the population is estimated to be approximately 1,900.

There are village halls in Halberton and Ash Thomas serving many community groups from both within and outside of the parish. The Farm Shop in Halberton has a wide draw and is used by people across Mid Devon.

# Parish Council - Community Engagement

Halberton Parish Council meets monthly, or more frequently if necessary, and meeting agenda and minutes are published on the parish website, along with other community notices and other general information for the whole community.

The Parish Council regularly engages with members of the public and the business community when considering Planning Applications and when Highways issues occur. The Parish Councillors and other community volunteers are very familiar with all parts of this rural parish and have much experience of listening to the public's view and presenting considered reports to MDDC as part of the Planning Process

The Parish Council publishes the Halberton Newsletter and Business Directory every two months, and printed copies are delivered by Halberton volunteers to <a href="every">every</a> household across the whole of Halberton parish. This service is provided at no cost to the public, being completely funded through advertising revenue. The newsletter and Parish website/facebook communicates reports and essential information to all parish members facilitating the transfer of information from other community groups to its audience.

### Halberton and the Parish Review

Halberton's Parish Council is responsible for representing a population of approximately 1,900 living across a large rural area of 3,054 Hectares.

In the context of the Parish Review that is taking place, the Parish Council believes that it is in the best interests of all residents across the parish to retain the existing parish boundaries with its neighbouring communities — Tiverton, Butterleigh, Cullompton, Willand, Uffculme, Burlescombe, Sampford Peverell and Uplowman.

The Parish Council believes that it represents the interests of its residents to a very high standard, reflected by the opinions of District and County councillors and others.

Halberton Parish has a very low population density and a large area . Due to its geography residents will often visit other community areas as well as Halberton Village , but this should not be a reason to alter existing boundaries .

This is a common feature of rural parishes across Devon where communities are predominantly made up of small hamlets.

The Parish Council is actively servicing all areas parish from village centre to outlying houses and farmsteads.

# **Considering the Aims of the Parish Review**

Mid Devon District Council has laid out a number of aims and objectives which the Parish Review might meet, and our report considered each of them.

**1** Altering anomalies when changes have occurred, meaning the current boundary is no longer relevant No significant changes have occurred recently to warrant any changes, the recent ward boundary review also came to this conclusion.

# 2 Changing boundaries as a result of new buildings and growth

Having stated that the existing boundary should be retained, it is accepted that the development of Lucombe Park is a significant extension of housing on the western edge of Uffculme into Halberton parish. Whereby this new housing estate could be incorporated into Uffculme Parish, we would argue that Halberton Parish has a good track record of looking after outlying areas. It is a quite a distance from any resources and should have some of its own, such as child's play park.

# 3 Local people have expressed views on the current structure

The Parish Council has not received any views objecting to the current boundary from any parish residents, either directly from the public or indirectly from other councils or agencies.

# To bring about improved community governance

No improvements of this nature have been proposed or can be envisaged. We have a good record of welcoming new councillors from any part of the Parish. Halberton Parish councillors are stated above, Halberton Parish Council represents the residents of Halberton Parish to a high standard, and strongly supports retaining the current parish structure and the vast majority of the existing parish boundary.

4 easily accessible and maintain regular communications with many within the Parish

# 5 To improve local democracy

Due to the large geographic area of Halberton Parish it could be considered to increase the number of polling

stations in the parish, but, with the increased ease of postal voting this may not be deemed necessary in the future.

# 6 To provide more effective and convenient local services

Since almost all local public services are provided by either MDDC or DCC, changing the parish boundary will not offer any improvement.

# 7 To improve or develop community identity.

Every road, Hamlet and Village builds a community irrespective of where boundaries lie. People will build friendships through schools, churches, interest groups and social media. Halberton parish has a strong inclusive identity promoting community throughout its parish and beyond.





I see absolutely no reason to change something that has worked since our Parish Boundary been in place all this time. I cannot see any benefit what soever. I have been on the Parish Council and am a Mid Devon District Councillor and a Devon County Councillor. I know it works well.

There will be no advantage to either Willand or Uffculme, if part of Halberton Parish is integrated into theirs. All services supplied by Devon County, Mid Devon District Council, Fire Authority, Police Authority, Health Authority, Highways, Social Services, Education, Planning matters and many other providers, all operate across Parish, District and County Boundaries.

The Parish Council produce a bi-monthly magazine which we hand deliver to all properties right up to our surrounding Parish Boundaries, our neighbouring Parishes are Willand, Uffculme, Burlescombe, Sampford Peverell, Tiverton and Cullompton. Within our Parish we have Hamlets of Ash Thomas, Brithem Bottom and many other smaller settlements.

I do not object to moving boundaries, if there is a proven need, here there is no proven need and it is a case of changing a boundary for the sake of change. Willand and Uffculme, nor anyone else can offer a better service and representation to the communities than Halberton Parish Council. We all work extremely well together and can and will continue to do so. This is nothing more than land grabbing, while trying to straighten up Boundaries into straight lines, this does not work. Nearly all Parish boundaries follow, either rivers, streams, roads, hedges, etc, this is impossible to do and has worked successfully for 150 years. We have the right number of Councillors to represent the Community and it's Residents.

Just as a matter of interest, two years ago, the same request was made by our two adjoining Parishes, Willand and Uffculme, to adjust the District Boundaries to match our Parish Boundaries, but the Inspector did not agree as we had put a convincing case not to do so and the Inspector decided in our favour to keep the District Boundaries as they are.

RESPONSE TO MDDC PARISH BOUNDARY REVIEW

Crediton Hamlet Parish Council has two Wards: Yeoford and Hookway. They are represented by five and four councillors respectively. Three of the Yeoford Ward

Councillors live within Yeoford and two live on the outskirts of Yeoford, but within the boundary of the Ward. The Hookway Ward is represented by councillors who live within the other hamlets of the Ward ie Uton, Venny Tedburn and Hookway. In addition, one longstanding councillor now lives in Crediton, but previously resided in Yeoford. He represents and is the main point of contact for residents in Westernlea which is adjacent to Crediton Town.

At the February meeting of Crediton Hamlets Parish Council, when addressing the review of Parish Council Boundaries, a small but vocal group (4 in total) of Yeoford village residents expressed the desire to have a Yeoford only Parish Council. The Council felt this was not in the best interests of the Parish as a whole and voted accordingly.

The following considerations influenced that decision:

The Parish has about 1000 residents, approximately 500 of whom are resident in Yeoford Village. The Council is careful to give due consideration to that concentration of residents and holds the half of its meetings in Yeoford where it is easy for villagers to attend and always holds its meetings in Yeoford when there is an item on the agenda which has a focus particular to that area.

The other half of meetings are held in Crediton to make it easier for residents from the other side of the Parish to attend. The meetings are held in Crediton only because, apart from Yeoford Community Hall, there is not a suitable venue in the Parish.

When vacancies on the Parish Council arise, Councillors are mindful of the balance of representation of the two Wards and are careful to ensure that Yeoford is fairly represented by Councillors. For example, when a longstanding Councillor from the

Yeoford Ward retired two years ago, Councillors ensured that the new Councillor lives in Yeoford.

The five Yeoford Ward councillors have excellent local knowledge about the thoughts and feelings of the bulk of the residents of Yeoford. They are well known in the community and easily contacted. Apart from the four residents who attended the February meeting, the Council has only received one letter in support of Yeoford having its own Parish Council. No other residents have contacted the Clerk, Council or individual Councillors and neither has any other correspondence has been received.

No parishioners from other parts of the Parish have contacted the Council expressing a desire to move to another parish. Usually residents only contact Parish Councils if they are not satisfied and therefore it should be assumed that the vast majority of parishioners are satisfied with the boundaries as they are now. It is important that his majority of residents is not disenfranchised from their participatory democracy by a small vocal minority.

There is a precedent for a larger village having its own Parish Council (Copplestone). However, Copplestone is a much larger and more dynamically evolving area where development is ongoing. Apart from very small scale developments Yeoford is unlikely to expand any more.

Reducing the size of the Parish Council area to one representing Yeoford alone does not offer value for money. A Clerk to the Council would be needed (at a similar costmto the one currently serving twice the number of people) and therefore less money would be available to spend on residents' needs. (Unless of course the Precept was significantly increased which might not be so popular with residents if they were aware of this consequence.)

Councillors are always aware of Yeoford's needs as the largest and most diverse settlement in the Parish and they work hard to ensure that it is treated fairly. For example, over the years Yeoford has benefitted from S106/CIL money generated from developments in other parts of the Parish Council area in the region of £27,000.

To put this in context, in the last twenty years the only significant development in

Yeoford has been Chapel Close which consists of three terraced, four detached and five affordable houses. Prior to this all development in Yeoford was in the 1980s and early 1990s. Should the boundary be changed, Yeoford village would no longer be able to benefit financially from such developments outside of the village.

In recent years Yeoford has received significant contributions towards its Play Area, Defibrillator, Community Gardening Project, Helicopter Landing Area and First Aid

Training. The Parish Council continue to support the provision of other facilities in Yeoford and the wider Parish.

The council has always applied due diligence when releasing funds for projects. This may have been perceived by some within Yeoford as an unnecessary hindrance but Councillors consider this to be proper administration of public funds.

Breaking up and annexing the outer lying communities of the Parish to neighbouring Parish Councils (which is what those seeking to make Yeoford a single Parish Council are campaigning for) not only loses valuable local communication networks and knowledge but does not improve the representation of those residents, as they will be equally distant from other centres of population. If you are representing small rural hamlets and villages, that are geographically distant from one another and want to do so with equity, you have to consider what is best for them and not defer necessarily to the slightly larger concentration of houses.

Historically Crediton Hamlets Parish has been represented as a separate entity to recognise residents' contributions in both World Wars both on the War Memorial located in Crediton High Street and at Remembrance Day Services.

Over many years Crediton Hamlets Parish Council has accumulated much local knowledge about local rights of way, footpaths, boundaries and the various villages and hamlets. This historical knowledge is very useful and helps inform decisions. It would be a shame to lose it.

## CONCLUSION

The current boundaries of Crediton Hamlets Parish Council work well and should not be changed. The above justification for leaving the boundaries as they are shows that it is perfectly possible for the Council to take account of the views and needs of ALL its residents and serve them ALL fairly. Yeoford is well and fairly represented now and would not be better represented if it had its own Parish Council. Dividing the area would only result in penalising other settlements in the Parish. The vocal views of a very small minority of residents should not be allowed to overrule the wishes of the silent majority.

- C. In the long-term, the Cullompton Garden Village should be a separate ward and the number of Cullompton Town Councillors increased in proportion to the number of residents.
- D. The Willand /Halberton / Cullompton boundary could be tidier so that the road is the boundary and doesn't leave and then re-join the same parish within a short distance.

# **Submission 73**

Copplestone Parish request that MDDC increase the number of Parish Council Seats from seven (7) to nine (9).

The following reasons for submitting this request are as follows.

- a. Membership of the Council has remained at seven since the formal inception of Copplestone Parish. Since this time, the size of the Parish has more than doubled. The ONS stats that as of December 2020, the population stood at just under 1500 persons. The Parish has grown in size with varying business of varying sizes being run from within the Parish by residents of Copplestone. Within the past 10-15 years there have been significant housing developments within the parish that have caused an influx of resident to the Parish. It is no longer a small Parish and is closing in on being a small town.
- b. With the increase in the population of the Parish, the Parish Council feel that two further seats on the council would allow more community involvement than is has now. For the first time in some years, there were two persons interested in being co-opted for a vacancy. This is unprecedented and shows that there is a demand to sit as a Parish Councillor.
- c. There are other Parishes within Mid Devon with a significantly smaller population (Zeal Monachorum) that have the same number of seats as Copplestone. Lapford Parish has 9 seats but a smaller population than Copplestone.
- d. Copplestone has in the past had issues with being quorate. At one point in time, there were four members only. In the space of 5 months thereafter, two meetings were not quorate due to illness or apologies being given.
  - It is felt that with more seats allowed, meetings would be quorate without having to factor in vacancies and absences that would push us over the watershed
- e. If the number of seats available is governed by the physical area of the Parish, this should be considered alongside the density of the population within the Parish. Copplestone has a dense population when compared to Down St Mary or Cruwys Morchard Parishes.

Halberton Parish Review - Notes

**Executive Summary** 

Halberton Parish Council is responding to the request from Mid Devon District Council to contribute to the Parish Review currently taking place across the district.

The Parish Council, in carrying out its duties for the residents of Halberton Parish, strongly supports retaining the current parish structure and the vast majority of the existing boundary.

It is recognised that the Lucombe Park development to the East of the parish is effectively an extension of Uffculme village and, for the benefit of those residents, Halberton Parish Council proposes that solely the Lucombe Park area of the parish be ceded to Uffculme parish. But could equally be serviced by Halberton Parish due to the proven track record of servicing outlying areas such as Ash Thomas, Brithem Bottom, Seckerleigh.

Halberton Parish Council has engaged with Uffculme and Willand parish councils regarding this Review, and strongly disagrees with their proposals to annexe other larger areas of Halberton Parish. Those proposals offer no tangible benefits to the affected population, whilst showing little or no respect for the neighbouring communities.

## The Parishes of Devon

Civil parishes can trace their origin to the ancient system of ecclesiastical parishes which historically played a role in both civil and ecclesiastical administration. Civil and religious parishes were formally split into two types in the 1860s and of course are now entirely separate.

#### **Halberton Parish**

Halberton's name is derived from "Haligbeort" (Albert), the name of the Saxon Chief, and "tun", a farm settlement.

Halberton was once important enough to be a "Hundred", an administrative division of a shire. This included the parishes of Halberton, Sampford Peverell and Willand, as well as parts of Uplowman and Burlescombe. Many of the farms date back to Doomsday or shortly after and Halberton is still largely a farming community with a strong rural identity.

### **Parish Communities**

In a rural District such as Mid-Devon, the communities outside of the main towns comprise a large number of small hamlets, some modest villages with limited services and a few larger villages with a wide range of services serving the immediate and surrounding areas.

In 2011, Halberton parish had a population of 1,765.

Of these, 865 lived in Halberton village and 900 lived in the outlying hamlets, including Ash Thomas, Brithem Bottom, Mountstephen and Selgars.

In 2022, prior to the 2021 Census being released, the population is estimated to be approximately 1,900. There are village halls in Halberton and Ash Thomas serving many community groups from both within and outside of the parish. The Farm Shop in Halberton has a wide draw and is used by people across Mid Devon.

### Parish Council – Community Engagement

Halberton Parish Council meets monthly, or more frequently if necessary, and meeting agenda and minutes are published on the parish website, along with other community notices and other general information for the whole community.

The Parish Council regularly engages with members of the public and the business community when considering Planning Applications and when Highways issues occur. The Parish Councillors and other community volunteers are very familiar with all parts of this rural parish and have much experience of listening to the public's view and presenting considered reports to MDDC as part of the Planning Process The Parish Council publishes the Halberton Newsletter and Business Directory every two months, and printed copies are delivered by Halberton volunteers to every household across the whole of Halberton parish. This service is provided at no cost to the public, being completely funded through advertising revenue. The newsletter and Parish website/facebook communicates reports and essential information to all parish members facilitating the transfer of information from other community groups to its audience .

### Halberton and the Parish Review

Halberton's Parish Council is responsible for representing a population of approximately 1,900 living across a large rural area of 3,054 Hectares.

In the context of the Parish Review that is taking place, the Parish Council believes that it is in the best interests of all residents across the parish to retain the existing parish boundaries with its neighbouring communities – Tiverton, Butterleigh, Cullompton, Willand, Uffculme, Burlescombe, Sampford Peverell and Uplowman.

The Parish Council believes that it represents the interests of its residents to a very high standard, reflected by the opinions of District and County councillors and others.

Halberton Parish has a very low population density and a large area . Due to its geography residents will often visit other community areas as well as Halberton Village , but this should not be a reason to alter existing boundaries .

This is a common feature of rural parishes across Devon where communities are predominantly made up of small hamlets.

The Parish Council is actively servicing all areas parish from village centre to outlying houses and farmsteads .

# Considering the Aims of the Parish Review

Mid Devon District Council has laid out a number of aims and objectives which the Parish Review might meet, and our report considered each of them.

1 Altering anomalies when changes have occurred, meaning the current boundary is no longer relevant No significant changes have occurred recently to warrant any changes, the recent ward boundary review also came to this conclusion.

# 2 Changing boundaries as a result of new buildings and growth

Having stated that the existing boundary should be retained, it is accepted that the development of Lucombe Park is a significant extension of housing on the western edge of Uffculme into Halberton parish. Whereby this new housing estate could be incorporated into Uffculme Parish, we would argue that Halberton Parish has a good track record of looking after outlying areas. It is a quite a distance from any resources and should have some of its own, such as child's play park.

# 3 Local people have expressed views on the current structure

The Parish Council has not received any views objecting to the current boundary from any parish residents, either directly from the public or indirectly from other councils or agencies.

### 4 To bring about improved community governance

No improvements of this nature have been proposed or can be envisaged. We have a good record of welcoming new councillors from any part of the Parish . Halberton Parish councillors are easily accessible and maintain regular communications with many within the Parish

### 5 To improve local democracy

Due to the large geographic area of Halberton Parish it could be considered to increase the number of polling stations in the parish, but, with the increased ease of postal voting this may not be deemed necessary in the future.

# 6 To provide more effective and convenient local services

Since almost all local public services are provided by either MDDC or DCC, changing the parish boundary will not offer any improvement.

# 7 To improve or develop community identity.

Every road, Hamlet and Village builds a community irrespective of where boundaries lie. People will build friendships through schools, churches, interest groups and social media. Halberton parish has a strong inclusive identity promoting community throughout its parish and beyond.

As stated above, Halberton Parish Council represents the residents of Halberton Parish to a high standard, and strongly supports retaining the current parish structure and the vast majority of the existing parish boundary.
