

## PRIVACY NOTICE - PLANNING REPRESENTATIONS

## **Processing your information**

All representations received in respect of a planning application will be processed in accordance with the Town and Country Planning (Development Management Procedure) (England) Order 2015. Please also see <a href="How to comment on Applications">How to comment on Applications</a> in order to protect data of others.

### Purpose of processing

Your information will be used by Mid Devon District Council (MDDC) in determining an application for planning permission and any representations received are published online on our public register and this includes your name and address. (Your personal email address, signatures and any contact numbers will be redacted from public viewing) but we will hold this information on our planning system.

Your information could also be used to contact you regarding the application for the following reasons:-

- 1. If the application is withdrawn
- 2. If the application is revised
- 3. When a decision is made
- 4. If the application is being heard at a committee
- 5. If an appeal is lodged

### **Accuracy of your information**

We will process the information given at the time of representation. If your information is not accurate then you can call us on 01884 255255. Alternatively if you used public access and registered online you will be able to manage this yourself.



#### Retention

Representations on applications will be held for a minimum of 12 months from the date of Decision or Appeal (whichever is later).

### Transferring Data outside of the EU

Your information will not be transferred outside the EU by MDDC, however anyone who has access to the internet can view the planning representations received, even if they have not registered.
