## Mid Devon District Council (the "Council")

### Mid Devon (Public Spaces Protection) (Dog Control) Variation Order No.3.

1. This Order is dated 19 June 2026
2. This Order shall be cited as the "Mid Devon (Public Spaces Protection) (Dog Control) Variation Order No 3".
3. This Order is made by the Council under sections 60 and 61 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act")
4. The Council in exercise of its powers under the Act and of all other enabling powers, after consultation carried out in accordance with the Act, and being satisfied that uncontrolled and irresponsible dog walking, including dog fouling, at

has a detrimental effect on the quality of life of the local community and that the conditions set out in Section 59 of the Act are met, hereby makes this Order

#### 1. DEFINITIONS AND INTERPRETATIONS

- 1.1 In the following provisions of this Order, the following terms shall have the meanings hereby respectively ascribed to them:-

"2021 Order" means the Mid Devon (Public Spaces Protection) (Dog Control) Order 2021 as amended by previous Orders

"Silverton Plan" means the plan attached to this Order and marked Plan 141

- 1.2 Except when the context otherwise requires, the singular includes the plural and vice-versa; and the masculine includes the feminine and vice-versa.
- 1.3 Reference to an Act of Parliament, statutory provision or statutory instrument includes a reference to that Act of Parliament, statutory provision or statutory instrument as amended, extended or re-enacted from time to time and to any regulations made under it.

#### 2. SCOPE

- 2.1 This Order varies the 2021 Order

### 3 VARIATION OF THE 2021 ORDER

3.1 The 2021 Order is hereby varied as follows:-

By adding to the 2021 Order the new requirements and prohibitions as set out in clause 4 of this Order to the recreation ground at Silverton

### 4 NEW PROHIBITIONS AND REQUIREMENTS

4.1 A Person in Charge of a dog is prohibited from taking that dog onto or permitting the dog to enter or remain on the land at the recreation ground at Silverton as shown edged red on Plan 141

4.2 By including in Schedule D to the 2021 Order the Silverton Plan after Plan 140

### 5 APPEAL

5.1 Any interested person (defined as an individual who lives in the restricted area or who regularly works in or visits that area) may question the validity of this Order, pursuant to Section 66 of the Act, on application made to the High Court within 6 weeks from the date of the Order.


### 6. VALIDITY (SEVERANCE)

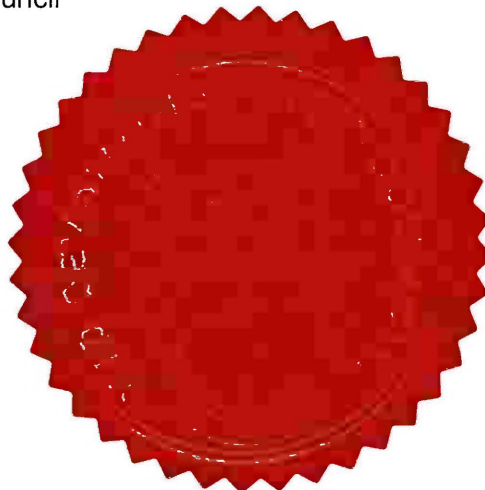

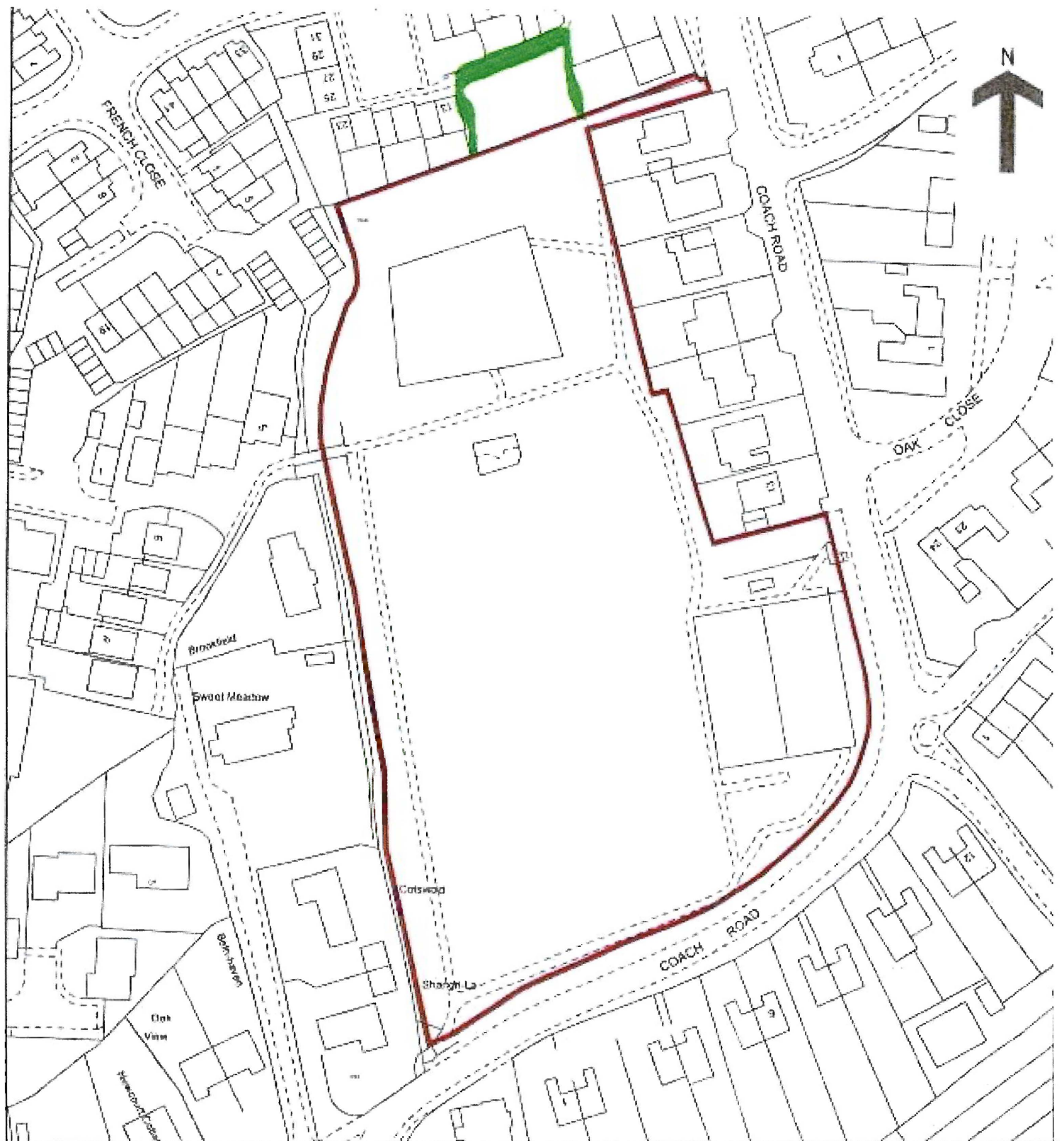
